I request that the name TekKcup be released and made available for use in the registration of TekKcup Inc.

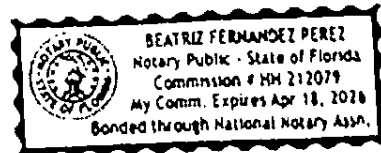
