The undersigned, subscriber to these Articles of Incorporation, a natural person competent to contract and a medical doctor duly licensed to render professional services as such, hereby associates herself in the formation of a professional corporation under the laws of the State of Florida, pursuant to the provisions of Chapter 621, Florida Statutes:

ARTICLE I CORPORATE NAME

The name of this corporation shall be D. Eliot Goldner, M.D., P.A. The corporation shall have perpetual existence.
